Sir,

With due respect, I have the honour to report the following few lines that on 29<sup>th</sup> May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of EngourokChingmang, Kanto Sabal and vandalized many houses of Meitei. In that incident, the Kuki armed militant broke in my house and looted electronic items such as refrigerator, washing machine, television, gas cylinder, etc. Also, had lotted an iron almirah in which jewellery estimated around 30(Thirty Thousand) included. The approximate value of looted properties is estimated around Rs. 2,00,000/- (Rupees Two Lakh) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
