In that incident, four numbers of cow had been killed by the Kuki militants. The approximate value of lost properties is estimated around Rs. 1,00,000/-(Rupees One Lakh) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
