With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and vandalized many houses of Meitei. In that incident, 5 numbers of cow, 10 numbers of piglet which was 3 months old had been killed by the Kuki militants. The approximate value of lost properties is estimated around Rs. 2,20,000/- (Rupees Two Lakh Twenty Thousand) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
