Sir,

With due respect, I have the honour to report the following few lines that, I am a residence of Leimakhong Chingmang, IW district which is under the control of Kuki arms militants since the beginning of the current communal riots. On 04/05/2023 at around 1:00 am some unknown arms persons suspected to be Kuki militants and Kuki rioters opened fire towards Meitei populace area of Leimakhong Chingmang village, IW district and torched, looted and vandalized many houses of Meitei. In that, I along with my family members have come out from my residence and taking shelter at house of one Kishorechand Singh located at Kanto Sabal, IW by keeping my house under locked and Key. On 29/05/2023, it comes to light that, the Kuki arms militant and Kuki rioters had trespass my house and looted my properties i.e furniture items, kitchen items, utensil items, clothing, electronics items, Cash (Rs. 2lakhs), jewelry and domestic animals (3 Cows, 2 goat and 1dog) by breaking the Lock and key which I had locked. The approximate value of looted & vandalized properties are estimated at Rs. 10,02,000/- (Rs. Ten lakh two thousand) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
