On 29/06/2023 at around 1:30 pm some unknown arms persons suspected to be Kuki militants opened fire towards Meitei populace area of Engourok Chingmang, Kanto Sabal, IW and looted/vandalized many houses of Meitei. In that, the unknown arms persons suspected to be Kuki militants had trespass my house and looted 4 nos. of cows. The approximate value of looted properties are estimated at Rs. 1,70,000/- (Rs. One Lakhs seventy thousand) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
