Sir,

With due respect, I have the honour to report the following few lines that, I am a residence of Khurkhul Makha Leikai, Imphal West district, my mix farm located at Khurkhul Singjapokpi which is under the control of Kuki arms militants since the beginning of the current communal riots. That on 11/08/2023 at 5:00 am, it comes to light that, some unknown persons suspected to be the Kuki arms militant and Kuki rioters had trespass my mix farm and Vandalized & looted all properties like furniture items, kitchen items, utensil items, clothing, electronics items, 20 no. of cows, 60 nos. of goat, fish, cow shed, goat shed, mix field (Potato, sugarcane, Tomato, King chilli & Maize), Fencing wire (Tara), fencing iron pillar, and others were looted as well as vandalized by the Kuki militants. The approximate value of looted/vandalized properties are estimated at Rs.54,65,300/- (Rupees fifty two lakh sixty five thousand three hundred) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
