With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Ex-Serviceman Colony, district which is under the control of Kuki arms militants since the beginning of the current ethnic violence. Due to the ongoing communal crisis between two communities, on 4/05/2023 at around 11:00 am, I along with my family members have come out from my residence and taking shelter at 165 TA, Thoubal by keeping my rented house under locked and Key. However, on 20/08/2023, it comes to light that, some unknown persons suspected Kuki arms militant holding sophisticated weapons had trespass my house and Vandalized my house i.e doors, windows and gate etc. The approximate value of the vandalized properties is about Rs. 1,00,000/- (Rs One Lakh).

It is therefore requested that you kindly look into the matter and take up necessary action at the earliest
