With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Ex-Serviceman Colony, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence. Due to the ongoing communal crisis between two communities, on 4/05/2023 at around 11:00 am, I along with my family members have come out from my residence and taking shelter Kanto Sabal Relief Camp by keeping my house under locked and Key. However, on 20/08/2023, it comes to light that, some unknown persons suspected Kuki arms militant holding sophisticated weapons had trespass my house and looted/Vandalized my properties i.e furniture items, kitchen items, utensil items, clothing items & electronics items, Cash (Rs One Lakh) and others by breaking the Lock and key which I had locked. The approximate value of the properties is Rs. 6,00,000/-(Rs Six Lakh).

It is therefore requested that you kindly look into the matter and take up necessary action at the earliest.
