I Thingujam Amujao Singh S/O (L) Th. Muhindro Singh R/O Leimakhgong Chingmang, Kanto, imphal West, Manipur 795002. I have honour to report that on Dated 29-05-2023 at around 3:00 P.M., a large number of kuki militant along with sophisticated weapons, have come and started firing against our village and started burned down our village houses. There after, I fled from our village and I stay for a while at kanto sabal Lampak. At that time, I come to know that my house were also burned down because of heavy smoke arises from the location of my house. I was very much shock and depressed upon that I was again afraid of kuki militants firing against us. So, I sit down at Kanto Sabal Lampak for a while and calm down myself. At around 4:30 pm I was hit by a bullet on my left chest. There after 7-10 mins I got unconscious. After I was got operated I got little conscious and come to know that I was in I.C.U.

I could not register my F.I.R on time due to lack of legal knowledge and also in misconception that F.I.R. has already lodge as my house were burnt down. Also, I have nobody to assist me. But, later on dated 19-05-2023, DALSA (District State Legal Service Authority) came to visit our Relief Camp where I am presently residing, I came to learned that F.I.R. without delay as soon as I came to know from the legal team of DALSA.

Brief Clinical Note The patient presented (L) sided chest pain, following a/h/o gunshot injury @ Leimakhong @ 5pm on 29/5/23. He was referred from JNIMS. NCCT thorax (29/5/23) showed (L) 5th-8th ribs # (L) lung contusion (L) hemopneumothorax. (L) tube Thoracostomy (L) done on 29/5/23 and removed on 3/6/23. He was admitted in TICU for 2 days. There was no post operative complication. His stay in the hospital was uneventful. He was hemodynamically stable at the time of discharge.

- Rx
- ① T. Augmentin duo 1g o—o after food x 3 days.
 - ② T. Prozo 40mg —o— before breakfast x 5 days.
 - ③ T. AB Flo SR o—o after food x 5 days.
 - ④ T. Zerodol SP —o— if pain
 - ⑤ Incentive spirometry.
 - ⑥ Tback ointment, to apply locally.
