Sir.

With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Chingmang, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence i.e 3rd May, 2023. Due to the ongoing communal crisis between two communities, in the intervening night of 18/6/2023 & 19/6/2023 some unknown persons suspected to be Kuki militants holding sophisticated weapons opened fire towards Meitei populace area of Leimakhong Chingmang, IW and torches many houses of Meitei community. As such, my whole family had fled away from my house due to fear & safe of our life and taking shelter at Konsa Khul, Leimakhong.

In that, the unknown armed miscreants had burnt down my house and whole the household properties i.e furniture items, electronics items, kitchen items, utensil items, clothing, cash (Rs 4,67,000) etc. The approximate value of the properties that were burnt down is about Rs 76,89,540/.

Regarding the matter, I couldn't able to report timely to your good office due to present ethnic communal violence in the state.

It is therefore requested you to kindly take up necessary legal action.
