Sir,

With due respect, I have the honour to report the following few lines that, I am resided at Leimakhong Ex-Servicemen Colony, Imphal West District which is under the control of Kuki arms militants since the beginning of the current ethnic violence. Due to the ongoing communal crisis between two communities, on 04/05/2023 at around 4:00 pm, I along with my family members have come out from my residence and taking shelter at Kanto Sabal Relief Camp for 1 month and now I along with my family stayed at the rented house located at Thangmeiband Hijam Dewan Leikai by keeping my house and Iron Workshop under locked and Key. However, on 08/08/2023, it comes to light that, some unknown persons suspected Kuki arms militant holding sophisticated weapons had trespass my house and Iron Workshop namely M/S Bijoya Laxmi Enterprise and looted my properties i.e, MS Iron rod, angle, MS Square pipe, MS round pipe and others by breaking the Lock and key. The approximate value of the properties is Rs. 5,00,000/- (Rs Five Lakhs) only.

It is therefore requested that you kindly look into the matter and take up necessary action at the earliest.
