In that, the unknown arms persons suspected to be Kuki militants had trespass my house and looted 4 nos. of cows and 20 nos. of ducks. The approximate value of looted properties are estimated at Rs. 1,70,000/- (Rs. One Lakh seventy thousand) approximately.


Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.
