On 29/06/2023 at around 1:10 pm some unknown arms persons suspected to be Kuki militants opened fire towards Meitei populace area of Keingam, Kanto Sabal, IW and looted many houses of Meitei. In that, the unknown arms persons suspected to be Kuki militants had trespass my house and looted 2 nos. of cows and 2 nos. of dogs. The approximate value of looted properties are estimated at Rs. 1,50,000/- (Rs. One Lakh fifty thousand) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
