Sir,

With due respect, I have the honour to report the following few lines that on 29th May 2023 some unknown persons suspected to be Kuki militants open fired towards Meitei populace of Engourok Chingmang, Kanto Sabal and Reimakhong Chingmang and burnt/vandalized many houses of Meitei. From the day of incident, 6 (six) number of cows had not returned, suspected to be killed by by Kuki militants. I also lost 2 (two) number of dogs and 55 (fifty five) number of ducks. The estimated value of lost properties is given as:-

① 6 cows (2 cow, 2 calf and 1 ox) = ₹ 90,000/-

② 55 ducks (3 months old) = $55 \times 500 = ₹ 27,500/-$

Total = ₹ 1,17,500

Regarding the matters I couldn't be able to report till date due to the present situation of the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
