Sir,

With due respect, I have the honour to report the following few lines that on 29<sup>th</sup> May 2023, some unknown persons suspected to be Kuki militants, open fired towards Meitei populace of Engouruk Chingmang, Leimakhong Chingmang and Kanto Sabal and burnt/vandalized many houses of Meitei. From the day of incident, 4 (four) number of cows had not returned home, suspected to be killed by Kuki militants. And several bullets reached Keingam, Kanto Sabal village so, due to fear of attack by Kuki militants, I along with my family members taking shelter at Kanto Sabal Primary School relief camp presently. The approximate value of lost properties is estimated around ₹ 70,000/- (Rupees Seventy Thousand).

Regarding the matters I couldn't be able to report till date due to the present situation of the state. Hence, I therefore reported to your good office for further procedure. It is therefore, requested to kindly look into the matter and take up necessary action at the earliest.
