Sir,

With due respect, I have the honour to report the following few lines that on 29th May 2023 at around 1:00 PM. Some persons suspected to be kuki militants open fired towards Meitei populace of Engourek Chingmay, Kanto Sabal and Leimakhong Chingmay and burnt/vandalized many houses of Meitei. From the day of incident, 3 (three) numbers of cows had not returned, suspected to be killed by kuki militants. In that incident of firing, several bullets reached my house i.e. at Keingam. Kanto Sabal and my dog had been killed by this bullet. Also, I lost 50 ducks and, 5 chicks and 3 pigs which is around 6 months old. The estimated value of lost properties is given as:

- ① 3 cows = Rs 50,000
- ② 50 ducks = Rs 30,000
- ③ 5 chicks = Rs 25.00
- ④ 3 Pigs = Rs 45,000

Regarding the matters, I couldn't be able to report till date due to the present situation of the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into matter and take up necessary action.
