of cows had not refused, suspected to be killed by kuki militarts. In that incident of fixing, several bullets reached

my house ie at keingam. kanto Sabal and my dog had been

kilfed by this bullet. Also, I lost 50 ducks and, 5 chicks

and 3 pigs which is around 6 months old. The estimated value of lost proporties is given as:

@ 3 cows = Rs 50,000

6 50 ducks = Ks 30,800

@ 5 Chicks = Rs 25 00

@ 3 Figs = R8 45,000

Regarding the matters, I couldn't be able to tuport fill date due to the present situation of the state. Hence, I therefore reported to your good office for further procedure. It is therefore, requested you to kindly look into matter and take up necessary action
