With due respect, I have the honour to report the following few lines that, I am a residence of Leimakhong Chingmang, IW district which is under the control of Kuki arms militants since the beginning of the current communal riots. On 03/05/2023 at around 8:00 pm some unknown person suspected to be Kuki militants opend fire towards Meitei populace area of Leimakhong Chingmang village, IW district and vandalized many houses of Meitei. In that, I along with my family members have come out from my residence and taking shelter at Relief camp Lamshang, IW by keeping my house under locked and key . On 20/08/2023 it comes to light from one of my neighbour (Nepali) that, the Kuki arms militants had trespass my house and vandalized my house as well as looted many valuable properties i.e House making goods GI sheet, Wooden, Iron, Furniture Items, Kitchen items, Utensil item, Clothing, Electronics items by breaking the lock and key which I had locked. The approximate value of the vandalized / looted properties is about Rs 2,50,000/-

Regarding the matter I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good officer four further procedure.

Its is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
