I, the undersigned would like to bring forth to your knowledge and report that I, am a permanent resident and native of Lalambung Makhong District Imphal West Manipur, P.O. & P.S. Lamphel belonging to Kuki tribe/community, recognized under the constitution of India. Thereby, I am entitled to the protection provided under The Prevention of Scheduled caste/ Scheduled Tribe Atrocities Act.

Shops Location: Gambier Singh Shopping Arcade Imphal  
Shop Number: 18 & 19 P/S: City Police Station, Imphal East

Due to the ethnic conflict prevalent in the State, some unknown well-armed radicals belonging to the Meetei/Meitei community, aided by State's Forces posted at various Valley-based Police outpost chanting anti Tribal Slogans on the 17<sup>th</sup> June 8 PM looted, vandalized, burnt/gutted my shop and all what is within the shop and its premise, owned and under my proprietorship, a total estimated amount of Rs 95 Lakhs was lost due to the illegal activities of the said armed-radical groups.

I, therefore kindly request you to please take action in this matter and come up with positive solution.
