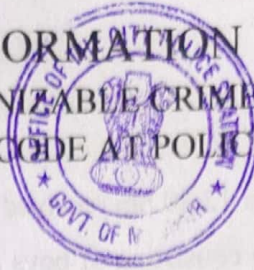

Today i.e. 26/9/2023 at 12:30 pm received an information that on the same day at about 12:25 pm a group of students consisting of boys and girls numbering about 300 students have suddenly rushed towards the southern gate of Raj Bhawan, Imphal along National Highway-02 from Shamu Makhong, Western Gate Kangla, BT road & Khoyathong side protesting against the killing of Phijam Hemajit Singh aged about 20 years S/o Ph. Ibungo Singh of Takyel Kolom Leikai and Luwangbi Lingthoingambi Hijam aged about 17 years D/o Hijam Kulajit Singh of Sagolband Tera Tongbram Leikai thereby breaking the duly promulgated prohibitory orders u/s. 144 Cr.P.C by the order of Hon'ble DM-Imphal West. The security personnel including women Police officers and men have given proper warning to disperse themselves. Instead of obeying instructions the students formed an unlawful assembly and started pelting stones towards the security personnel. Having no option the Police party with the order of Executive Magistrate, Imphal West have dispersed the unruly student mob by using non-lethal minimum forces & mild means. In the melee few student agitators sustains injuries on their persons.

Hence, a Suo-motu case under FIR No. 59(06)2023 City-PS U/s. 147/149/188/152/336/353 IPC has been registered for investigation.
