Subject: - Report.


Sir,

With due respect I have the honour to state that today i.e. 13/10/2023 at about 2:25 pm while I was performing my duty near Congress Bhavan Gate, BT Road, Imphal. During my duty hour some members of Manipur Pradesh Youth Congress committee (MPYCC) and other Political Parties numbering about 250/300 marched toward Raj Bhawan, Imphal thereby breaking the duly promulgated prohibitory orders u/s. 144 Cr.P.C vide order No. DM(IW)/I/57/CON/2009-Pt(III) dtd. 8/10/2023 of Hon'ble ADM-Imphal West. So I along with police personnel tried to stop them from marching toward Raj Bhavan. The security personnel including women Police officers and men have given proper warning to disperse themselves. Instead of obeying instructions the protesters became more aggressive towards the security personnel and they provoke against the police personnel with a manner that obstructing the lawful discharging of duty. The police personnel led by Addl. SP (LO)-IW, SDPO-Imphal, OC, City-PS tried to disperse the mob in that some protester led by (I) Achoibam Deben Singh (42 yrs) S/o. A. Rabango Singh of Lamalai & (II) Ningthoujam Popilal Singh (27 yrs) S/o. N. Ramesh Singh of Phayeng assaulted me resulting into injury to my body and they also torn my uniform. Soon, I was evacuated to RIMS, Imphal for medical treatment.


It is therefore requested to kindly take up necessary legal action against them as per law.


