Sir,

I am to state that, on 4th May 2023, at around 3pm, our locality Khongsai Veng, Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house No. **165** (Permanent Residence) was also destroyed by the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed includes:

1. Immovable properties like House having **House Rent Pucca Building**
2. Movable properties
 - a) Gold & jewelry **3 Gold Necklace(8 San)**
 - b) Granary & Grain **2 bage rice 10 Bage rice grain**
 - c) Documents. **School Certificate,**
 - d) Vehicle **Nil**
 - e) Furniture **3-seleping beds 3 almirah 01 Dresing table etc**
 - f) Traditional Ornaments **30 traditional ornaments**
 - g) Modern and traditional garments. **40 pc**
 - h) Gass book **04 cylinder Gass Book 01 gass stove 01 etc**
 - i) Electronic items. **1 wash Macine Led tv Etc**
 - j) Cash. **30,00,00/-**

Total loss of properties at my residence would be above Rs. **30,00,00 /-**

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police station as I had fled from my residence to safe myself and my families from the rioters.
