I have the honour to state that, on 4th May, 2023 at around 9:00 AM some unknown miscreants belonging to Meitei Youths Organization suspected to be members of Arambai Tenggol who are loyal group to the present Inner MP, **Shri Leishemba Sanajaoba**, World Meitei Council (WMC), Meetei Leepul and Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC), Manipur Police And Commandos numbering about 1000+ members carrying sophisticated weapons like AK rifles, 303 Rifles, SBBL, Pistol, Molotov, etc. with vehicles forcefully entered in my village located at **National Game Village, Langol, Zone IV, D-4, Imphal West**. They looted all valuables and vandalized my house, moveable properties and leaving us homeless. The approximate value of lost and destroyed properties to be about 25 lacs.

It is therefore, requested to kindly registered a regular case and take necessary legal action according to law.
