Sir, I am to state that on 4th May 2023 at about 3PM on locality zone-III (three) A/100, National games village under Lamphel police station, Imphal west was under mob attack by some miscreants belonging to Meitei community with an intention to murder

As a result many properties worth lakhs were stolen & destroyed.

Properties looted and destroyed include:

1. Furniture: Double beds - 6nos, mattress - 6nos, Almirah - 4nos, Dressing table - 2nos, sofa set - 2nos, Dining table set, TV. stand, Gas stove, Gas cylinder refilled - 6nos.
2. Electronics items: Fridge, TV., Laptop - 3nos, digital camera, washing machine, microwave - oven, wireless Radio set - 4nos, stand fan - 3nos, electric guitar.
3. Grains: Husked rice - 75 kg, Un-Husked rice - 50 bags
4. Vehicles: Alloy wheel K16 with Michelin Tyre 4piece
5. Cash: Rs 2,30,000
6. Jewellery: Gold chain (7saw), Gold ring (1saw)
7. Traditional Necklaces - 4nos. (Klichang), Traditional longis
8. Documents: All education certificate, Bank passbook, ATM card - 2nos
9. Pets: Goats - 7.

Total lost of property of my quarter zone 3, A/100 would be estimated about 30 lakhs.

I therefore kindly requested that necessary action should be legally taken immediately
