With due respect I would like to lodge FIR on
the above cited subject that, On the intervene night
of 4th May 2023 at 1:30 AM, A group of Manipuri
speaking youths numbering around 30 to 40
came and attacked my Quarter No. D-7, Zone IV
without any provocation, They had mortal weapons
in hand including iron rods, Guns and Swords
thereby vandalising ① One Govt. Vehicle (Van) Bearing
Regd. No. MNOGL-4799, belonging to Directorate of
Social Welfare. and ② One Access 125 Scooty with
Regd. No. MNOIA-D4870. ③ One Sony Bravia 83cm T.V.
④ Samsung 3 Door Refrigerator. ⑤ 2 Complete set of
Computer Desktop with printer ⑥ Dressing Table and
3 wall clocks. ⑦ Kitchen Almirah ⑧ Gas Stove
⑨ Godrej Almirah and its contents worth huge
amounts, (Gold ornaments and cash) ⑩ Sintex water
Storage. ⑪ Stolen materials 2 Bicycles 2 Helmets
and One laptop and one Mobile Handset.
An estimated lost of property damaged and
theft in terms of money value stands at not
than Rs. 10 lakhs worth.

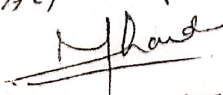
