I am to state that, on 4th May 2023, at around 3pm, our locality Khongsai Veng, Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house No. 21 (C) (Rent Residence) was also destroyed by the mob, many properties were burnt and leftover looted. This report is freefed as OF of the ease FIR. No. 39315)
