that, on 4th May, 2023 at around 11:00 am unknown miscreants suspected to be Akambai Tenggal, Kanglupak Kanba Lup (KKL), Meitei Leepun numbering about hundreds and thousand attacked on our locality i.e. Laiphom Khunou (near Khongsai Veng) Imphal East P.S. Heingang Manipur and looted all properties in the house. The approximate value of properties lost/damaged is estimated to be about 29,50,000/- (Twenty nine lakh fifty thousand)

I could not report the incident to my concerned police station in time due to the prevailing law and order situation of our state.

I, therefore request your good office to kindly take up necessary action in this regard.
