Subject - First Information Report

Sir,

I am to report a that on 04/05/2023 at around 1.30 p.m. a huge angry mob numbering about 500/600 armed with deadly weapons like sticks, iron rods, daos, catapults, inflammable materials etc ransacked, vandalized my residential house which is a G+2 building located at Chassad Avenue (Nongpok Ingkhol). They destroyed the entire building, looted all items stored inside and set fire to it. My neighbours doused the fire after the mob left the place. My relative with family who were presently occupying my house fled fearing for their lives. The value of the property destroyed can be estimated at around 1.2 crores. Photographs of the property destroyed will be produced when required.

The incident could not be reported timely due to the prevailing situation and safety reasons.

It is therefore, requested to kindly take necessary action at the earliest
