In that unfortunate incidents I have lost a total amount Rs. 10,00,000/- (Ten Lakhs Cash, furniture and household) After the said unfortunate incident/mob violence my family are fleeing our village and my family is taking shelter at a relief camp (IMA CHINGJROI RELIEF CAMP)


