I, Hindangmayum Dhananjoy Sharma, son of (Late) Hindangmayum Kalachand Sharma owner of this hotel would like to state that a large group of armed militants belongs to a community stormed to my hotel at around 3.am on May 4th nearly burnt down the hotel as well as vandalized my hotel items and looted namely Gold Jewellery, Electronic items, Household items, Furniture items, even stole cash around 50,00,000 (fifty lakhs). I have lost my property approximately Rs 1,7,80,000 worth items.

Household item worth Rs 20,00,000 (twenty lakhs)

Electronic item worth Rs 3,00,000 (three lakhs)

Gold Jewellery items worth Rs 30,00,00 (thirty lakhs)

Vehicle (2 wheeler) worth Rs 80,000

Furniture items worth Rs 4,00,000 (four lakhs).

I, therefore would like to request that you kindly take legal action against these accused who done inhumane acts and heinous crime involving all these crimes.
