Sir

On the 4<sup>th</sup> of May, 2023 afternoon, around 1000 youth suspected to be Arambai Tenggot group from the Meitei community carried guns, ammunitions and other deadly weapons, attacked the Hachip Veng, near Palace compound, Imphal East. We fled and hid in different places to save our life. On that same day, after we fled and the following days, they had destroyed locked doors, looted every pieces of our properties, burnt down our garage with vehicles and buildings.

Among the houses they have been burnt, all document / certificates were also completely destroyed.

I therefore request to booked the culprit and take necessary action as per the law of the land.

Details of destroyed items:

House (Rent) - 200000 (orange colour) Reg. no. MIDIAH-3347, cycle, laptop - dell, Bed - 2, Mattress - 2, Amritah, Syntex - 3, Cylinder - 3, Gas stove, Rice - 3 bag, Blanket - 6, Table, chair, induction, fridge, washing Machine, clothings, Flat TV, Books collection and many valuable items etc.
