Sir,

I have the honour to report that on 3rd May, 2023 at about 9:30 pm unknown entirely mob numbering about 200-300 armed with deadly weapons suddenly attacked my residence and burnt down to ash all my properties i.e TV, Washing Machine, Ggs. Cloths and 30 rice bags etc. and belongings kept at Safe Godrej i.e cash Rs 1.20, 000/- (One lakh and twenty thousand) and gold ornaments were also turn to ash including all the important documents. The approximate value of properties lost and damaged is estimated to be 15,00,000/- (Fifteen Lakhs).

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the State.

It is therefore requested to kindly take up necessary legal action in this regard. Thanking you.
