Sir,

With due respect, I have the honour to state few lines for your kind consideration and necessary action.

That on 4<sup>th</sup> May 2023 at around 8:00 pm, unknown miscreants suspected to be Arambai Tengot Kangleipak Komba Lop, Meitei depen, numbering about 200 - 300 armed with deadly weapons suddenly attacked our locality i.e Chassad Avenue, 11E District Manipur and looted all my properties including all the important documents from my house and destroyed my house including - 1 (one) Tata Pupiter four wheeler Blegd no. MNV - 5787 and 1 (one) Dio Honda two wheeler Blegd no MN 01U - 1478. The approximate value of properties lost / damaged is estimated to be about 3 (three) crore.

I could not report the incident to my concerned PS as well as in time due to prevailing law and order situation in the state.

I therefore request your good office to kindly take up necessary action in this regard.
