With due respect, I have the honour to state
few lines for your kind consideration and necessary
action.

That on 4th May 2023 at around 8:00 pm, unknown
miscreants suspected to be Nombak Tengol, Kangpokpi
Kambei Sup, Meitei Keipun numbering about 200-300
armed with deadly weapons suddenly attacked our
locality i.e. Chassad Avenue, Imphal East District,
Manipur and looted all my properties including all the
important documents from my house and destroyed
my house. ^{one kinetic round was} The approximate value of properties
lost/damaged is estimated to be about 1.50 crores.

I could not report the incident to my
concerned Police Station as well as in time
due to the prevailing law and order situation
in the state.

I therefore request your good office to
kindly take up necessary action in this regard.
