Sir,

With due respect and humble submission, I,
Akhingthong Haskip of Bemkhonch Kuki of Chassed Avenue,
Imphal East would like to file a complaint against on
properties and Parlour shop damaged on the 4th & 5th May 2023.

My Parlour shop and properties which is located
at Chassed Avenue, Imphal East have been vandalized
and all properties including important personal file,
documents and all machinery goods have been looted and
destroyed as well as threatening of life, attempted murder
by using machete and physically assaulted by the
majority Meitei / Meitei community. The approximate
value of lost destroyed and looted properties is
estimated to be about 30 lakhs.

As the law and order situation is not good
in the area. I could not complaint in my respective
police station as well in time.

The following items of land and properties were
destroyed and looted are as follows:

- 1) Parlour shop items and furniture's
- 2) Other Movable and Immovable item.

I therefore kindly request you to take necessary
