My Parlour shop and properties which is located at Chessed Avenue, Imphal East have been Vandaliyed and all properties including important personal file, documents and all machinery goods have been looted and destroyed as well as threatening of life, attempted murder by using machete and physically assaulted by the majority Meitei / Meeler community. The approximate value of lost destroyed and looted properties is estimated to be about 30 lakhs.

As the law and order situation is not good in the area. I could not complain in my respective police station as well in time.
