buring the course of enquiry, examined some PWs in c/w the enquiry. On enquiry, it has been ascertained that on 29/6/2023 at about 8:10 p.m. members of Meira Paibi, Keirao Wangkem were watching TV news at Keirao Wangkem Meira Paibi Club (Sanglen) at the said time. The alleged persons namely (1) Pukhrambam Hemanta Singh aged about 45 years (2) Pukhrambam Jiten Singh both are s/o (L) P. Ibohal Singh of Keirao Wangkhem Mamang Leikai along with P. Hamanta,s wife had aggressively came at the club and had exchanged some derogatory and obscene words with Phijam Kamala (Adviser of Keirao Wangkem Apunba Meira Paibi Lup) over the refundment of money which was taken in the name of giving Ujwala Gas. In that he used abusive words intending to insult the modesty of women and defaming them by uttering derogatory words using slang languages. He also showed humiliated and degraded nature under the influence of alcohol. The interference by the local club member into the matter is also found to be true which caused the physical tussle among themselves. As a result of which Ch. Samananda Singh sustained injury on his body which was caused by deadly weapons like spade and axe.

During preliminary enquiry, it is ascertained that on 29/6/2023 at about 8:10 p.m. there was a tussle between alleged persons (1) Pukhrambam Hemanta Singh (45) and (2) Pukhrambam Jiten Singh (37) years both are s/o (L) P. Ibohal Singh of Keirao Wangkhem Mamang Leikai and Phijim Kamala Devi and Meirapaibies of Keirao Wangkhem along with local club members in which the alleged person used derogatory words which amounts to outraging modesty of women. It is, therefore, submitted for kind perusal and further necessary action please.

As per endorsement, I have the honour to submit the enquiry report that on 10/06/2023 at 6:10 pm the namely complainant namely Chingakham (O) Pebam (N) Baby Devi of Keirao Wangkhem, Imphal East District, Manipur reported to OC IBG PS. The brief of the complaint report:

- 1. That, on 29/6/2023 at about 8:10 p.m. alleged persons (1) Pukhrambam Hemanta Singh (45) and (2) Pukhrambam Jiten Singh (37) years both are s/o (L) P. Ibohal Singh of Keirao Wangkhem Mamang Leikai entered into the Keirao Wangkhem Meira ibiClub(Sanglen) and stand before the T.V. while Meira Paibiswere listening T.V. news of Current Issues of Manipur. Thereafter Pukhrambam Hemanta Singh start scolding the Meira Paibi with slang words/language in connection with present issues of Manipur but none of the Meira Paibi responded at first time. On the other hand the some male members of Keirao Wangkhem Club also nearby Meira Sanglen and amongst those club members one member simply said it is not good to say such a language in front of womenfolk. Soon after, the Pukhrambam Hemanta Singh rushed to his residence and came out along with Pukhrambam Jiten Singh and other their family members in furtherance of the common intention entered into the Meira Sanglen with deadly weapon in their hands and Pukhrambam Hemanta Singh start soughing as under: "Wangkhem Keiraogi meirapaibi singdi eina lupa chamanga piraga eigi nupi loina oihanba ngami..... makhoi khudingmak oktabi ngangtni" (English translation, all the members of Wangkhem Keirao Meirapaibi are prostitute, I can hired them as my wife by paying Rs 500/-) then he shows his naked private part/organ before the all the meira paibis present inside Meira Sanglen and thereby cause offensive to modesty and decency to all the woman society and as such some male club volunteers tired to pulled him out and start fighting amongst themselves.
 - 2. That, Complainant's husband is very responsible person of club of Keirao Wangkhem and good social worker having good moral character, he rushed to the spot and tried to stop fighting both parties but P. Jiten Sing physically assaulted by kicking and punching on his body and at the same time P. Hamanta singh strike by his Yompak on complainant husband. As a result of which complain- ant's husband receive injury on his hand and some other body parts and evacuated to hospital for medical treatment.
 - 3. That, Surprisingly the accused person family members also without any knowledge of the matter, rushed and attempt with deadly weapons and start beating against the complainant's husband and Phijam Kamal Devi (Secretary of Meira Paibi Club) and one boy namely Imoson and thereby got grievous injuries to them. Imoson have got serious injury at his sophisticated area of neck and he was fallen down inside the drain and it may caused death at the spot. That, the complainant's husband and other injury persons were brought by Club members and rushed at JNIMS Porompat, Manipur for treatment for their grievous hurt.
 - 4. That, the complainant has no other means except complaint/report to the police concerned for cruelty against women and for harassment of female at public place and crimina forces to Meirapaibi/women folk intending outrage her modesty and showing his naked body/testicle by P. Hamanta Singh in the public place that also before the woman folks. Hence the enquiry and the same is endorsed to me for enquiry and report.
