

Sir,

Most humbly and respectfully, I have the honour to report that, today i.e. 24/07/2023 at around 1:45 am, my Honda Activa Blue in colour bearing regd. No. MN06SE 8118 which was parked inside my courtyard with proper lock and key was stolen by unknown person. On hearing the ignition engine sound of the Honda Activa, my brother namely, Athokpam Malemnganba Meitei chased the thief driving his i20 bearing regd. no MN01S 5314 towards Okram Chuthek.
