From the enquiry conducted so far, it has been ascertained that on 27/08/2023 at about 07:00 pm the complainant went to the house of Laimayum Joypal Singh (40) S/o (L) L. Iboyaima of Kongba Kshetri Leikai under Irilbung Police Station where his wife namely Laimayum Romita Devi was residing temporarily after separation to see his wife. Before going inside the house of Laimayum Joypal Singh, his vehicle Santro Car bearing registration no. MNO1W-9619 dashed against the gate of Laimayum Joypal Singh. Then, Laimayum Joypal Singh and his cousin Haorungbam Yohenba (21) S/o H. Khambaton of Sekta Loushangkhong, Imphal East District A/P residing at the house of Laimayum Joypal Singh came out of his house. Further, Joypal and his cousin Yohenba equipped with deadly weapons like bamboo stick, iron rod etc. started attacking him and as a result he sustained injuries on his person but the complainant could not produced any medical relevant documents to prove his injury. Further, they damaged his vehicle Santro Car bearing registration no. MNO1W-9619. As a result of which the backside window and side window glasses were broken into pieces. Meanwhile the local people gathered at the spot and extended helping hand and he met good escape from the crime scene.

I find a prima facie evidence to substantiate the charge against Laimayum Joypal Singh (40) S/o (L) L. Iboyaima of Kongba Kshetri Leikai and Haorungbam Yohenba (21) S/o H. Khambaton of Sekta Loushangkhong A/P residing at the house of Laimayum Joypal Singh.

It is, therefore, requested you kindly to take legal action against them according to law.

The brief fact of the case is that on 30/08/2023 at about 04:00 pm Ningombam Roshankumar (43 yrs) S/o N. Ibohal Singh of Khurai Chingambam Leikai lodged a written report with the Officer-in-Charge, Irilbung Police Station alleging that he was a married man and have 3 children (two daughters and one son). Since, the month of Feb. 2022, he got separated with his wife namely Laimayum Romita Devi and she had been living at her parental house at Kongba Kshetri Leikai at the residence of Laimayum Joypal Singh (40 yrs) S/o (L) L. Iboyaima. That he has been living with his children and they communicated frequently with their mother keeping the relationship of a mother and her children bounded. On the morning of 27/08/2023 at around 8:30 am he took his three children to his wife's parental house at Kongba Kshetri Leikai so that they could meet their mother, but their maternal grandmother and uncle Laimayum Joypal Singh told that their mother is not there, so they returned sadly.

That on the same day at around 7:00 pm, he re-visited at Kongba Kshetri Leikai to enquire whereabouts of his wife, but on reaching the gate Laimayum Joypal Singh S/o (L) L. Iboyaima. He (Laimayum Joypal Singh) along with one youth namely Yohenba started attacking him with deadly weapons including bamboo stick and iron rod. In which he got badly injured and his vehicle got partly damaged (backside window and side window glasses were broken). The local people help him and he escaped from the scene.

He couldn't report the matter timely, as he got confined to bed rest due to the injuries which he had sustained. Hence the report.

On receipt of the aforementioned report, OC/IBG-PS entered the content of the report in the General Diary of Irilbung PS vide G.D Entry No. 19/IBG-PS/2023 dated 30/8/2023 for enquiry into the matter and entrusted the report to me for enquiry. Hence, I have taken up the report and enquiry was carried out accordingly.

During the course of enquiry, examined the complainant thoroughly and tactfully where his statement has fully corroborated with the report lodged by him. A detail of his statement is recorded U/S 161 Cr.P.C. Visited the spot and inspected the P.O with the drawing of the rough sketch map of the P.O. No incriminating articles were found from the spot. Further, examined some PWs in c/w the report.
