




Today i.e. 17/9/2023 at 12:57 a.m, received an information that on the same day at about 12:30 a.m a group of unknown youths numbering about 60/70 stormed at the residence of Subedar Laitonjam Bebekananda Singh, OC-Special Commando, situated at Kongba Kshetri Leikai, Imphal East District, Manipur. The unknown youths pelted stones thereby damaging plastic chairs, CCTV cameras installed at his residence and window glasses. The unknown youths were dispersed by the team of Irilbung Police Station and Special CDO/IE teams by firing tear gas shells etc. However, there is no report of casualty.

In this regard, a case under FIR No. 54(9)2023 IBG-PS U/S 147/148/149/427 IPC is registered Suo Mottu for investigation.
