
Subject : Report.


Sir,

I have the honour to state that, on 03-06-2023 at around 05:30 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol, World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) and Women wings, numbering about 600-700 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our village, Monglham village, having 65 houses, under Island Sub-Division, Kangpokpi District, Manipur about 80 Km East from Saikul-PS. After looting all the moveable properties including Domestic animal and cattles, they vandalised and burnt down all our house including Church and Church properties, Church Office, Primary School, UJB School, Community Hall, Granaries and all the household properties to the ground leaving all of us homeless. The approximate value of properties destroyed is calculated at about Rs. 65,00,00,000/- (sixty five crores).


It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
