



With due respect I beg to report you with reference to the above subject that on 17/11/2023 at around 11:30 p.m. some unknown persons numbering about 12 persons covering their faces by cloths and holding guns (small arms), entered my residence and tried to kidnap me but they released me because my son cried and request them. The unknown persons were communicated with Hindi language. Thereafter, the following items has been looted by those unknown persons –
