Subject: Complaint regarding destruction and damage of Elisha Inter Community Zion Church, Nungbrang.

Sir.

As you aware a communal clash erupted in the state on 3<sup>rd</sup> May, 2023 leading to grave loss of life and widespread destruction of personal and public properties including place of worship. Amidst this violence on 4<sup>th</sup> May, 2023 at around 4:00 pm the building of Elisha Inter Community Zion Church, Nungbrang, PS- Andro District- Imphal East Manipur with several properties of the church were burnt down and destroyed by a mob of around (200 to 300).

The following is a details description of the loss of properties that we suffered:-

Apart from the loss of Church properties due to the absolute breakdown of law and order in our state some members of Elisha Inter community Zion Church Nunbrang, have been directly and indirectly threatened to renounce our Christian faith and accept the indigenous faith (Meitei Laining) and even mocked at.

In this regard it is requested to intervene in this matter urgently and protect Church members, properties and further loss and damage. We also request you to submit computation of the loss to our properties mention above to any appropriate body of the state Govt. to grant us the compensation at earliest. So, that we need to rebuild our church.

It may be mentioned here that there was a delay in reporting the incident to police due to the threats and discriminations mentioned above and reports of more severe such threats to Christians in other parts of the state.
