Today i.e. 28/05/2023 at around 05:05 pm a large number of peoples including men and women numbering about 5000 were rounded at Andro Police Station from different direction and they forcibly enter inside the campus of Andro Police Station holding with deadly weapons including Arms, Stick, Iron rods etc. In order to prevent the unruly mob, Police teams of Andro PS including CAPF (C-Company 149 BN CRPF) team deployed at Andro Police Station and team of Shri N. Suraj Singh, MPS, Dy- CO 2MR have expanded anti Riots equipment like mob bomb, tear gas shell etc. But all efforts were in vain due to the large number of unruly mob and they over power all the police force. In that the police force and CAPF (C-Company 149 BN CRPF) have fire live round as last option. In this incident three civilians from the mob have injured and evacuated to Hospital for medical treatment. The unruly mob later enter inside the police station campus and broken arm kote and forcibly snatched away the following arms and ammunition. Beside the unruly mob also snatch away arms and ammunition day today used by personnel and also some important document/paper which is confidential also lost during the mob. The mob also damages the office building. The unruly mob also set on fire the campus of the police station. However the fire is completely extinguished with all the effort of the Police teams and CAPF including fireman of Yairipok fire sub - station at 11:30 pm. The unruly mob continues their activities till about 9:00 pm of today. In this confrontation some police personnel were also injured.

And also snatched away 12 Nos. of Bullet proof jacket having BP plate (including 4 numbers of escort team of Dy. Co/ 2nd MR), 13 Nos. of BP Helmets (including 4 nos. of BP helmet of Escort team of Dy. Co/ 2nd MR), 3 Nos. of Cane sticks, 4 Nos. of Shield Guard, and One Motorola handheld set SL. No. 038TN7062/ bearing model no. AZM27JNH9LA2AN. One number of AK Rifles along with two magazine having 50 live rounds bearing Regd. No. AE-44-5556 and Anti Riot Gun bearing Regd. No. 167113957 of Shri N. Suraj Singh, MPS, Dy. - CO 2MR escort team was also partly burnt by the fire. In this incident an amount of around Rs. 8000/- (Eight Thousand only) which was collected through TR Challan and kept inside a trunk box was also taken away by the mob. Beside this a two wheeler vehicle was also party damage by bullet.

Hence, a Suo Mottu case under case FIR No. 199(05)2023 APS u/s 147/148/149/447/427/384/436/34 IPC and 25(1-C) A. Act is registered for investigation.
