With reference to SP Ukhrul order no. C-1(G/P)/2023-SP(UKL)/9319 Dated 28/11/2023, a combined team of Ukhrul District Police, 6<sup>th</sup> MR, DFO/UKL, NAB and village volunteers, led by Shri. Ringthing Hongchui, MPS, Addl.SP(Ops) Ukhrul, under the supervision of Superintendent of Police, Ukhrul, Conducted destruction of illegal poppy cultivations at Tangkhul Hundung village hill range, about 53 km South from Litan Police Station, Latitude – 24.836836° N and Longitude – 94.207443° E w.e.f. 30/11/2023 to 01/12/2023 from 10:00 AM to 4:00 PM by the order of SDM/Phungyar who furnished the attachment and destruction order of the illegal poppy cultivation U/S 48 ND&PS Act.1985. An area of about 36 (thirty-six) acres approximately was destroyed. It is expected to yield about 360 (three hundred sixty) Kg, 10(ten) kg per acre, worth Rs. 3,60,00,000/- (three crore and sixty lakh only), Rs. 1 lakh per kg. None came forward to claim the ownership of the illicit poppy cultivated land. So, some poppy pods were seized for inducing evidence if required in the court of law and for taking further Legal necessary action.

Hence, a regular case on Suo-motu under FIR No. 20(12)2023 LTN – PS U/S 18(b) ND & PS Act, has been registered for Investigation.
