Subject: - First Information Report (F.I.R.)

I have the honour to say a few lines for your kind consideration that around 17:15 hrs of dated 28/05/2023 that large number of peoples including men and women numbering about 5000 were rounded at Andro police station from different direction and they forcibly enter inside the campus of Andro police station holding deadly weapons including arms, stick, iron rods etc. Local villagers surrounded Andro PS with an intention to loot the kote. They started to pelt stones on kote; Jawan barrak under PS and windows were shattered to create panic among force personnel. Adhering maximum restraint force personnel tried to push them back with physical force. Strength of force was not adequate to tackle these hooligans but 34 available personnel (C-149bn) reflect exemplary restraint in dealing with these unwanted circumstances. Meanwhile villagers started to advance towards the PS and tried to snatch weapons from personnel. After proper warning, I ordered to fire T.S.M after that blank rounds and finally myself and my team opened air fire. Sensing the gravity of matter QAT of sub units under command of Cheetah Swatantra Kumar reacted swiftly with alarming fire in air to control the uncontrolled mob. Despite of all efforts villagers were adamant to loot the kote. After exploring all modalities to thwart the evil intention of mob troops resorted to fire last option after which the mob dispersed. It has been reported that villagers may attack in night also. I have warned to the marching mob not to enter our campus. But they refused to do so. They finally tried to enter our arm kote. By this time our party bravely confronts the mob and started air fire to save the kote and other related kote materials. Thus, I Cheetah Swatantra Kumar (Asst.Comdt), along with ASI/GD Pratap Chandra Naik, HC/GD Kuldeep Singh, CT/GD Gulam Hassain and CT/GD Kumod Kumar of C/149 bn. CRPF did extremely brave job without the fear of our life and our party also fight this critical situation as a brave true soldiers. During this action we fired total 4 Nos. of T.S.M, 3 nos. of Blank rounds and 104 Nos. of live rounds. Later the unruly mob also set on fire the campus of the Police Station. However, the fire is completely extinguished with all the effort of the available deployed personnel (01 platoon of C-149 BN) with police teams in Andro PS, fireman of Yairipok fire sub - station at 11:30 pm. The unruly mob continues their activities till about 9:00 pm of date 28/05/2023.

Due to exemplary effort PF QAT under able command of Cheetah Swatantra Kumar all weapons are safe in kote and nefarious design of hooligans has been thwarted. Details report follows.
