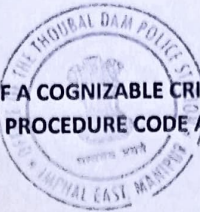

Subject:- First Information Report on Burning and Looting of Union Ministry of Women and Child Development Funded NGO Home "SHAKTI SADAN" and privately run "CHILDREN HOME FOR GIRLS".

Sir,

With due respect, I would like to report that on the 5th Of May, 2023 at around 6:30 pm unknown miscreants believed to be volunteers and supporters of Arambai Tenggol, Meetei Leepun, Kangleipak Kanba Lup, Haomee Federation and local youths of the nearby villages of Nongpok Keithelmanbi and Nungbrang attacked and burnt down the above mentioned homes after looting all available items as below:

- All ICARD files and records including Society Registration Certificates, Memorandum, Bye-Laws, Cash Books, Vouchers, Balance Sheets, Annual Reports, Photo Albums, various registers etc
- 120 (hundred and twenty) number of iron cots, mattresses, blankets, pillows, bed sheets,
- 2 (two) 48" smart TVs, (iv) 2 (two) Inverters with battery each, (v) 4 (four) 3x8 white boards,
- 2(two) Refrigerators, (vii) 6 (six) filled gas cylinders, (viii) 4 (four) high flame gas stoves, numerous kitchen wares and utensils, (ix) 100 (hundred) each od benches and desks,
- 50 (fifty) cloth cupboards (xi) 1 (one) 5KV Generator (xii) Games and Sports materials
- Personal belongings of 100 residents/beneficiaries including academic books (xiv) 4 x 1000 litres Water storage tank-Sintex, (xv) 8 channel CCTV Camera installation, etc

The destroyed standing structures include;

- 4 (four) dormitory rooms, (ii) 2 (two) counseling rooms, (iii) 2 (two) office rooms,
- 2 (two) visitors' rooms, (v) 2 (two) recreation rooms, (vi) 2 (two) dining halls,
- 2 (two) kitchens, (viii) 4 (four) staff bed rooms, (ix) 8 (eight) bathrooms,
- 12 (twelve) toilet rooms etc..

I, therefore, request you to do the needful in this regard as per law.
