Subject:- First Information Report on Burning and Looting of Common Service Point (CSP) of State Bank of India linked with SBI-Yairipok Branch.

Sir,

With due respect, I would like to report that on the 5th Of May, 2023 at around 6:30 pm unknown miscreants believed to be volunteers and supporters of Arambai Tenggol, Meetei Leepun, Kangleipak Kanba Lup, Haomee Federation and local youths of the nearby villages of Nongpok Keithelmanbi and Nungbrang attacked and burnt down the above mentioned CSP after looting all available items as below:

- (i) All CSP files and records including Registration Certificates, Cash Books, Vouchers, Photo Albums, various registers and Certificates, etc
- (ii) 1 (one) 48" smart TVs,
- (iii) 1 (one) Inverters with battery,
- (iv) 50 (fifty) cloth cupboards
- (v) 1 (one) 5KV Generator
- (vi) 1 x 1000 litres Water storage tank-Sintex,
- (vii) 8 channel CCTV Camera installation,
- (viii) CSP Lap Top Sony Vaio
- (ix) RD Morpho
- (x) Micro ATM machine,
- (xi) 1 HP Laserjet Printer
- (xii) 1 Epson Inkjet Printer,
- (xiii) Furnitures and Fixtures, etc

The destroyed standing structures include;

- (i) 4 (Four) rooms pucca building of the CSP.

I, therefore, request you to do the needful in this regard as per law.
