Sir.

With due respect, I would like to report that on the 5th 0f May, 2023 at around 6:30 pm unknown miscreants believed to be volunteers and supporters of Arambai Tenggol, Meetei Leepun, Kangleipak Kanba Lup, Haomee Federation and local youths of the nearby villages of Nongpok Keithelmanbi and Nungbrang attacked and burnt down the above mentioned CSP after looting all available items as below:

- (i) All CSP files and records including Registration Certificates, Cash Books, Vouchers, Photo Albums, various registers and Certificates, etc
- (ii) 1 (one) 48" smart TVs,
- (iii) 1 (one) Inverters with battery,
- (iv) 50 (fifty) cloth cupboards
- (v) 1 (one) 5KV Generator
- (vi) 1 x 1000 litres Water storage tank-Sintex,
- (vii)8 channel CCTV Camera installation,
- (viii)CSP Lap Top Sony Vaio
- (ix) RD Morpho
- (x) Micro ATM machine,
- (xi) 1 HP Laserjet Printer
- (xii) 1 Epson Inkjet Printer,
- (xiii) Furnitures and Fixtures, etc
