



With humble submission I Lamminhao Vaiphei Kamuching village, Kangpokpi District under Maphou Police Station, Manipur beg to Inform you that large number of miscreants belonging to majority Meitei community came to the Kamuching village Kangpokpi District Manipur and burn down all my properties, House, Documents etc. on Date 04/05/2023 at around 2:00 pm. Total loses of my properties would be about Rs- 2000000 (twenty Lakhs) approximately, without any reason is highly condemnable and totally uncalled for booking of the culprits under appropriate section of the Indian Penal Code.

The situation was highly chaotic and could not identify the individuals who is committed the crime. But I can say that most of them wear T- Shirt, red marks at the back of T-Shirt. They are fully with weapons attacked and attempted our lives. We have been in the forest striving hard for more than 3 days, luckily 33AR and 13GR posted in Andro evacuated us from the forest

So, I kindly request you to take further necessary action on this matter. And I have enclosed the list of properties looted, burnt down by the said miscreants on the same days
